Adult Confirmation and First Holy Communion

Registration Packet

Our preparation for adults needing First Holy Communion and/or Confirmation is an intense process for adults who were baptized in the Catholic Church and who need to complete their sacraments of initiation. The process includes catechetical classes, reading assignments, and attendance at liturgical celebrations of our parish.

What: Preparation for adult Catholics who are seeking the sacraments of Confirmation and First Holy Communion.

When: Classes will generally be held on Thursday evenings at 6:30 PM, twice a month, beginning on September 8th, 2011. A few additional sessions will be required, such as the Parish Mission and liturgical celebrations of Holy Week.

Where: Most of the classes will be held in the St. Anthony Classroom at St. Francis of Assisi Catholic Church.

Important: It is important that those who are completing their sacramental initiation into the Catholic Church be in a regular marital situation. For Catholics, this means either single living chastely or married in the Catholic Church. It is important to fill out all of the registration forms as thoroughly as possible so that we can assist those who may need additional pastoral care or preparation in this area.

Fee: The fee for the process is \$140. This covers all of your books, parish expenses, etc. This may be paid all at once or in payments. There is also a \$25 Confirmation Gown Fee due two weeks before the Confirmation Mass.

To Register:

IMPORTANT: Register early! The size of the rooms available may limit class size to 40.

Registration is first come, first served.

- Please fill out the entire packet.
- Return the packet to the parish Faith Formation Office along with a check for the \$140 Registration Fee.
- Additionally: You will need to obtain a **NEW** official copy of your baptism certificate "**WITH NOTATIONS**" from the Catholic Church where you were baptized. This can easily be done by a simple Internet search and phone call. This is due by November 1st, 2011.
